## **Re: CORRECTION OF YOUR NOMINATION FILES**

Subsequent to the closure of nomination period and evaluation of your nomination files, only two member organisations have fully complied with the nomination requirements.

Amongst the key requirements needed to ensure adherence to were submissions of the following also taking into consideration the contents of Election Guidelines sent with that letter:

1. *A resolution confirming such nomination which must be signed by both the President and the Secretary General of the nominating national federation;*
2. *A cover page of the nominating federation minutes of a meeting where such resolution to nominate a person was reached clearly indicating members attendance as per the national federation constitution's requirement; and*
3. *A comprehensive profile of the Nominee (maximum two (2) pages).*

*ONLY submissions from National Federations in good standing will be accepted.*

You are in receipt of this letter because your National Federation failed to comply and therefore the LNOC Executive Board recommended to the *Election Committee – Transformation Resource Centre* of which endorsed, to allow for resubmission of pending items in order to improve your submitted file(s) to the required applicable standards.

Resubmissions of pending items or improved files should be submitted to the Secretary General of the LNOC on or before *13h00 of Friday the 03<sup>rd</sup> February 2017*.

**Conditions of resubmission:**

- i. Only names of nominees submitted on or before the 31<sup>st</sup> January 2017 will be accepted – NO NEW NOMINATION OF NOMINEES ALLOWED;
- ii. No resubmission will be accepted after the above specified deadline.

Enclosed herein **ANNEXURE 1** shows the National Federations that are due to make necessary resubmissions and their areas of improvement. Please pay attention to all the details before you make your final resubmission in order for your file to be compliant.
